Brandywine Raceway, the new \$2,000,000 harness racing oval under construction near Wilmington, has voluntarily reduced the number of racing nights for its inaugural season from 30 to 20 nights, starting Sept. 7, George T. Weymouth, president, announced Tuesday night. The action was taken to assure the harmonious support of the three harness racing associations in Delaware, Weymouth said.

The meet originally was scheduled from Sept. 7 to Oct. 10, but the last ten programs have been cancelled.



Each farmer enrolling will be asked to supply information on his practices and operations. Judges will score the forage program on each enrollee's farm at least twice during the season. Emphasis will be placed on the possibilities of improvement in the program, within the farmer's facilities and resources.

A change over last year's program is that farmers who received "Excellent" ratings in 1952's Green Pastures Progarm will not be eligible to enroll Their names will be inscribed on a permanent honor roll, and they will be asked to sponsor a new enrolee on the program.

Enrollment blanks are available from the County Extension office in Newark, Dover, or Georgetown. These blanks should be filled out and returned to the county agricultural agents by April 15.
