

## Lake Forest bus drivers go to school

Line up and proceed to class. These four Lake Forest School bus drivers were among thirty who took advantage of inservice training offered in the states new School Bus Driver Training Unit.

"A bus driver is a person who smiles in the morning and smiles in the evening and eats Roloids in between." He "...gets there when nobody else can -- finds houses which don't exist and children with no names."

When State Specialist School Bus Driver Trainer Bernard P. Malone passes out the literature containing the above observations for the Wyoming Educator, local school bus drivers smiles, or maybe groan, in agreement. But the smiles are mere grace votes to the more serious business that gets them to volunteer two and a half hours of their time - the safety of Delaware's school children. Their concerns also include conservation of fuel and equipment and learning ways to make the often harrowing job safer and easier.

To these ends they are all participants in a training program offered aboard a vehicle Bernard Malone feels may be unique in the country - the School Bus Driver Training Unit. In operation just since mid-January, the unit is actually a 72 passenger school bus especially designed and equipped to offer both classroom and on the road instruction to school bus drivers. It is intended as an in-service program to supplement the eight hours of instruction each driver must take in order to operate a school bus. The bus was obtained by the state's Department of Public Instruction with a \$42,930 grant from the Federal Office of Highway Safety. It was furnished and equipped by the Bluebird Bus Company.

Participation in the program is strictly voluntary. But according

to Malone, the rate of volunteers has been high. When the unit was in the Lake Forest District last week, thirty of the thirty-two local drivers took advantage of the opportunity to improve their driving skills and safety know-how.

First in the program is classroom instruction in the rear area of the bus which contains a full range of projection equipment as well as physical testing equipment and several operating mechanical models of engines, transmissions and other parts.

Films, filmstrip and slides deal with various aspects of traffic safety and with such techniques for defensive driving as the Smith system for keeping a space cushion between the vehicle and other traffic.

The physical testing equipment

includes an automatic reaction timer, a vision testing machine, a night sight meter and a steadiness tester. These are used to help drivers evaluate their own reactions. Tips are given to help individuals cope with any problems they might have.

Moving to the front of their model classroom, drivers get to take the vehicle on the road through the actual traffic conditions in their own district. The front area is furnished to accommodate the instructor and four drivers. As each driver takes a turn at the wheel, his classmates get a chance to learn from his strengths and help him evaluate any weaknesses. But the emphasis is on the strengths. And most drivers find they have something to learn from each other.

## Three Nabbed After Robbery

Three Williamsville men who entered the Harrington residence of William A. Wheeler and, at gun point, took \$52 from the purse of his daughter Mildred Coeyman last Tuesday were quickly nabbed by police. The three - Albert Lee Benton (20), Bruce Lynn Benton (18), and Glenn Darrell Vincent (20) were arrested at their Williamsville home just three hours after the incident. They were committed to Sussex Correctional Institute in lieu of \$20,000 bond each.

According to local police reports the three, wearing masks, first entered a garage at the Wheeler residence where they ransacked a car. Then they pro-

ceeded through a door into the kitchen area where they were surprised by Mrs. Coeyman.

Brandishing guns, the three demanded money, but were turned down. At this point, one of the three took Mrs. Coeyman's purse into a nearby bathroom and removed \$52.

Undaunted by the three handguns that were still being pointed at her, Mrs. Coeyman told the intruders "You boys could get into a lot of trouble for this. Why don't you just leave." And that's what they did. Apparently feeling they had been recognized, the three fled the scene.

A call to the police at 8:20 p.m. brought results by 11:20 the same

night. Based on a description of the three by Mrs. Coeyman and other evidence at the scene Corporal P. Lawson of Troop 5 of the Delaware State Police, and Chief Carl McIlroy and Patrolman Peter Bohn of the Harrington City police traced the three to their home. Evidence found there led to their arrest. They were arraigned at J.P. Court 3 in Georgetown and incarcerated at Sussex Correctional Institute in lieu of a total of \$60,000 in bonds.

At the time of the incident both the Bentons and Vincent were free on bond pending trial for the January burglaries at L & D Electronics and Burton's Sport Shop in Harrington.

## Harrington City Council:

### No layoffs, no raises, no deficit

The Harrington City Council told the city's employees last week they would all have jobs for 1980. But none of them would get raises. The Council, in efforts to eliminate a \$19,000 plus deficit, cut \$8,677.28 in proposed raises for its employees from the proposed budget.

This measure and several others proposed by Councilman Jack Wyatt shaved the necessary \$19,000 from the projected expenses and made it possible for the Council to adopt a balanced budget without raising the tax rate.

Other items trimmed from the budget included \$5,000 for a drainage project on North Street, \$4,000 to buy a used truck classes for use on the city's large flat bed, \$1,000 from the \$2,000 to be set aside for police overtime, and \$400 from miscellaneous funds.

The decision to rehire all personnel and the action taken on most of the budget cuts were unanimous. But there was agonizing over the choice to eliminate pay raises for city employees. The Council split 4-2 over the final decision, with Councilmen Brode, Dill, Lobo and Wyatt voting for

A dispute between the salaries paid to boys' and girls' track coaches may be a part of the problem.

Until a girls' coach can be found, boys' track coach Jim Blades has offered to shoulder the extra responsibility. The Lake Forest Board accepted his offer and decided to pay him the

additional salary the girls' coach would receive on a pro-rated basis until his replacement can be found.

Jim Fleming will assist Blades with the boys' track team. In other appointments Bill Falasco will again accept responsibility for the varsity baseball team; Randy Ward will take the J.V. team, and Al Wood, who took his girls to a state championship last year, will coach the girls softball team at Lake Forest High School. The board also agreed to let Wood, who has health problems, hire a helper to be paid partially from his own salary and partially from the athletes budget. Brad

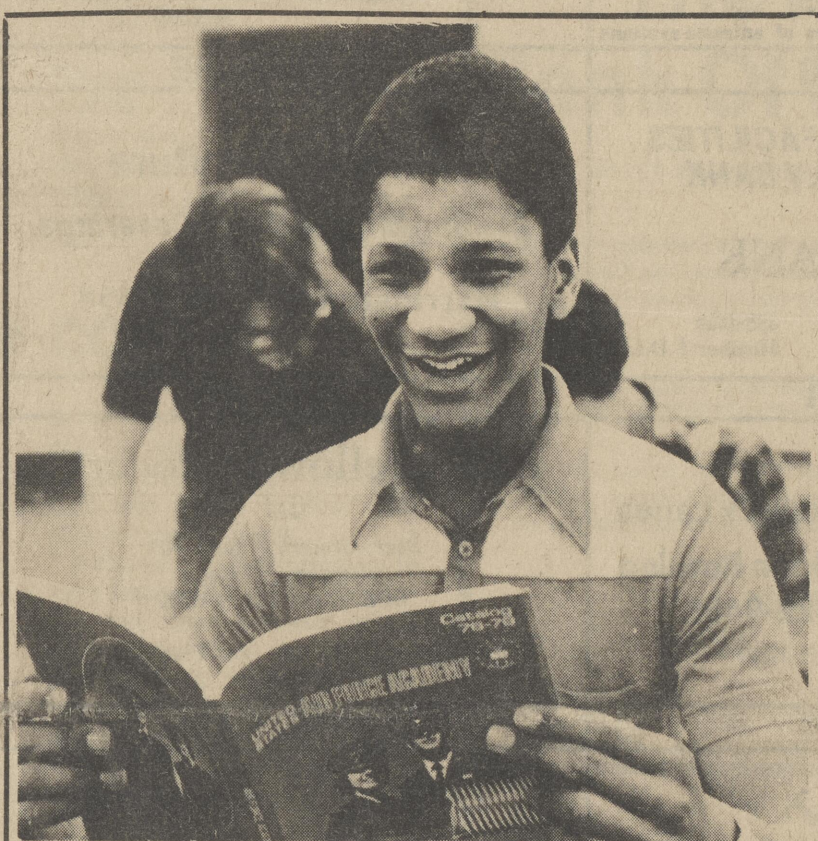

## Harrington, Dennis & Crew To The Rescue

Fourteen-year-old Ed Cope is a lucky young man - lucky to have an observant neighbor who quickly discovered his plight when he fell through the ice on Wyoming Pond Friday, and lucky that a crew of local men from the Delmarva Power and Light Company was working nearby and could come to his rescue.

Gary Harrington, James D. Dennis, and Jim Fitzhugh (all of Harrington) and Woodrow Martin (of Houston) were working at removing a tree in front on the neighbor's house when she came to them for help. According to Gary Harrington she came asking if they had a rope and could reach a youngster who had gone through thin ice on the pond about 100 yards behind her home. The men quickly gathered rope and a ladder, thinking the boy was probably a few feet from shore. They discovered, instead, that he was thirty yards out into the pond and up to his shoulders in icy waters that had nearly immobilized him.

Repeated attempts to toss the rope to the boy failed, even when

## Flamer Gets Death Penalty

William Henry Flamer, convicted on four counts of murder in the deaths of his aunt and uncle Alberta and Bayard Smith last February, has been sentenced to hang on March 28. But charges against Andre Deputy, his alleged partner in the crime, have been dropped.

The charges against Deputy were dropped following a ruling by Superior Court Judge William G. Bush III that evidence the state has against him is inadmissible because he was illegally detained at the time of his arrest. Deputy was picked up because he was walking with Flamer. Bush said police had no reason to suspect Deputy at that time and that any evidence they got from him then is inadmissible. The evidence includes Deputy's taped statement admitting his involvement and personal property allegedly taken from the Smiths.

Without that evidence, the state feels it has no case against him. Judge Bush's ruling is being appealed to Delaware Supreme Court.

A ruling by Judge Bush that a taped statement Flamer said was coerced from him was a admissible is likewise the basis of his attorneys' appeal of his murder conviction. The death penalty will wait the outcome if that appeal and probably also the result of the challenge to Delaware's death penalty law by convicted murderer Frank Cole Whalen.

Andre Deputy is currently serving 30 years on an unrelated manslaughter conviction.

## Bus driver training (Cont.)

Two other features help drivers in the "on the road" portion of the training. The first of these is equipment which allows the driver to simulate the conditions, with lights and signals, of stopping and starting, loading and unloading children without really holding up traffic as they would in the actual situation. This helps drivers strengthen all-important safety procedures in the loading and discharge of students.

The second feature is an AWARE System, a device which beeps at the driver when he misuses his equipment in some such way as last minute braking. The system also records the number of misuses for each trip so the drivers are given additional information for their self evaluation.

If the number of misuses is high, an individual may need to improve for the sake of safety as well as for the conservation of his vehicle and the fuel he uses.

Following the on-the-road training is an evaluation period with time perhaps for more films.

Bernard Malone had words of commendation for local bus drivers and others throughout the state who take their own time to participate in the training. He is attempting, at present to make the 2 1/2 hour course available in each school district in Delaware.

After the initial go-round, he expects to bring the unit back to the districts for a second training period in which he hopes to increase the on-the-road portion of the program.

living in fixed incomes in his ward could not stand having their taxes raised, Dill said the Council had no choice but "--bite the bullet."

Brode and Lobo expressed similar feelings in voting for the measure. Brode said "I'd rather cut off raises than lay off people."

For two Council members, Gary Harrington and the Rev. Ray Newman, the bitter pill was harder to swallow. Before voting against the pay raise cut, Harrington said, "We ask these people (city employees) for performance -- They're affected by the same 14% inflation that we are."

Mayor Cahall, also opposed to the elimination of pay raises, could not vote since there was no tie. But he said, "I don't think it's right to make city employees pay for something that could have been avoided completely. (We) shouldn't take it out on city personnel caught up in the same problems we are."

With the deficit eliminated the City Council was able to set this year's tax rate at \$1.00 per \$100 of 60% of the assessed value of property, the same as last year.

It was also able to give final approval to a \$368,000 budget for 1980. Although it is several months into the fiscal year, the Council's budget decision beats last year when it was March before the financial hassle was settled.

**-Willis Rezoning Still in Limbo-**  
Several proposals were offered to set a public opinion referendum

on the rezoning of a portion of Dudley Willis' Harrington property from industrial to residential. But the Council wanted legal assurances from City Solicitor Harry Terry that an agreement could be worked out limiting the apartments Case-Edwards wants to build there to senior citizens. The question remained on the table after the Council met in executive session with Terry. Presumably, the matter will be further researched before the next meeting.

### -Ordinance Change Proposed-

The Council last Tuesday proposed to change the ordinance which allows only the Mayor to make appointments to the Planning and Zoning Commission. At the January reorganization meeting the Council ignored Cahall's appointment of Charlotte Gagne in favor of its own candidate, Ellen Perry. At the next meeting the Mayor pointed out the Council had acted illegally, and the appointment of Mrs. Perry was invalid.

The ordinance change would let the Council propose its own candidate if the Mayor's appointment were rejected.

In other business the Harrington City Council:

-asked City Manager Dave Peterson to come up with a monthly report detailing the current status of properties which the City would like to have repaired or condemned. At present there are nine properties

under consideration. -agreed to invite State Librarian Sylvia Short to the next regular meeting to discuss the future of the Harrington Public Library. With the approval of the budget, the City has guaranteed the library \$2,644 to continue in

operation from July 1 to the end of the fiscal year. But Ms. Short is seeking a longer term commitment.

-changed the date of the next regular Council meeting to Wednesday, March 12, at 7:30 p.m.

it was weighted with a plank of wood found nearby. At this point, Harrington, a swimmer, waded into the pond, thinking he could reach the youngster. Breaking his way through surface ice, bone chilling water and mud that made footing treacherous, he soon discovered he would be unable to make it. He was forced to give up the effort to wade out to the boy.

Fortunately for Ed Cope, his rescuers were able to locate a neighbor's small boat which they

used to get out to him and pull him to safety. Harrington and Dennis manned the boat; Fitzhugh and Martin assisted with efforts from the shore.

Although taken immediately to Kent General Hospital, Harrington and Cope suffered no ill effects from their icy dunking. Harrington did experience a few muscle cramps which the doctor said were the result of the sudden halt to the strenuous rescue activities.

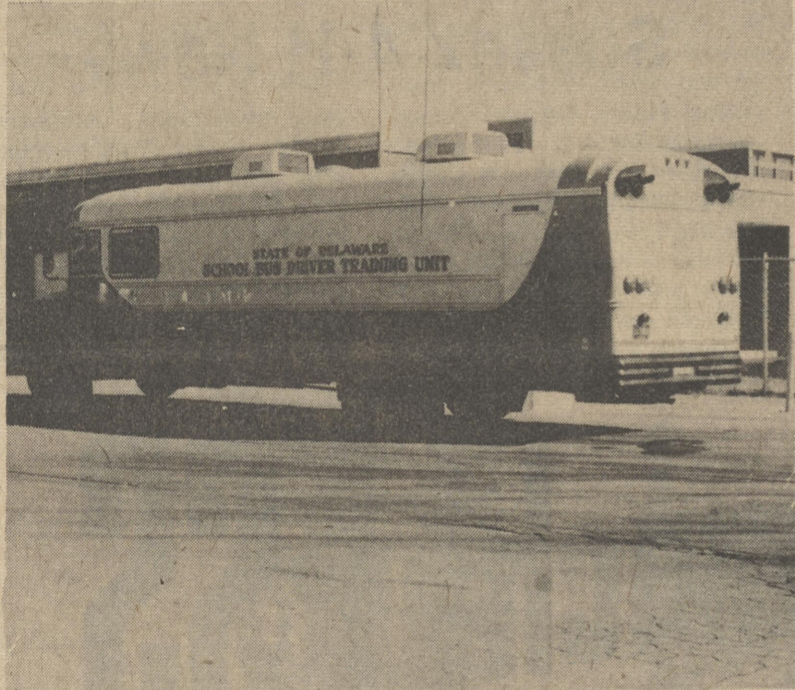

High school sophomores and juniors with passing grade average are eligible to compete for the title of Delmarva Poultry Princess, a \$1,000 scholarship to the school of her choice, a \$200 gift certificate from Hess Apparel and a weekend at the Carousel in Ocean City, Maryland. A contestant must reside in or attend school in the community she represents. She cannot represent a county, school district or business.

Judging will be based upon five equally weighted areas: achievement and service; poise and appearance; personality and attitude; interview, and creative expression in the form of a three minute talent presentation.

Preschool youngsters will compete for the title of Little Del-

marva Poultry Princess, a \$200 United States Savings Bond and gift certificates from Lad n Lassie and Walls' Childrens Shops. Contestants in this category must have had their fourth birthday but not have reached their sixth birthday by July 1, 1980. They must reside in or attend school in the community they represent. Judging will be based on personality, poise, appearance and presentation of a brief recitation.

There are two ways to enter the Delmarva Poultry Princess Pageants. If a preliminary pageant is being held within a community, all entries from that community will be handled by the local committee. The winner of each local pageant becomes a candidate in the Delmarva finals.

If there is no community pageant, entry is made through the atlarge program. An official application is completed and mailed with a recent photograph to Delmarva Poultry Industry.

## Soybean Advisory Board to be elected

The Delaware Department of Agriculture announced that election of the first Soybean Advisory Board will be held between March 1 and March 15, 1980. Secretary Alden S. Hopkins, Jr. said that the Department has received eighteen nominations from the Delaware Crop Improvement Association's nominating committee for the nine board positions. However, Secretary Hopkins explained that the balance will provide for additional write-in candidates.

The nominees selected for the first Soybean Advisory Board are: From New Castle County: Warren Baker, William Cross, Henry Retz, and Nicholas Uniatowski. From Kent County: H. Ronald Collison, Olin Gooden, Joe Hughes, Clifton Thompson, C. Wesley Webb, and George Wilson, Jr. From Sussex County: Donnell Calhoun, Clark Calloway, Robert E. Dukes, John Hastings,

Earl L. Isaacs, Jr., Clifton R. Parker, Jr., William Vandervende and Robert E. West.

This is the first of the two elections required by Delaware Law to complete a commodity check-off referendum. Ballots for the election of the Advisory Board will be mailed to Delaware Soybean Producers prior to March 1. Any producer not receiving a ballot by mail will be able to obtain one by contacting the Department or the local Cooperative Extension Office.

The Soybean Advisory Board drafts the soybean development order. It is the development order that specifies how much money will be collected and how the monies will be used. After public hearings on the order a second election will be ordered by the Secretary of Agriculture to allow the state soybean producers to vote on the development order.

## Feb.17-23 is Rotary International Week

The week of February 17-23, 1980 has been proclaimed Rotary International Week in Delaware by Gov. Pierre S. DuPont in recognition of Rotary's 75th Anniversary.

Gov. DuPont called on Delawareans to observe the week with appropriate recognition, pointing out that Rotary's world-wide creed is "Service Beyond Self".

DuPont's proclamation noted

that Rotary was organized in Chicago in 1905 by Paul Harris. He invited four fellow businessmen to combine their ideas and ideals at a weekly luncheon meeting. It has grown to 18,342 clubs with 853,000 members who live in 153 different countries and geographical regions.

It also noted that Rotarians contributed \$15 million last year to promote programs for educa-

tors and young men and women for travel world-wide for advancement of international understanding, good will and peace.

George F. Adams of Milford, Delaware is governor of District 763 of Rotary, embracing 29 clubs in Delaware and on the Eastern Shore of Maryland. The district has about 1,300 members.

funded and expanded for the coming year.

Huffman told board members high Delaware unemployment figures about 50% of which represent young people between 18 and 24 prompted the concern which sparked the program. He said Jobs for Delaware Graduates is aimed at students who will receive general education diplomas who may lack the skills attitudes and motivation necessary to secure and keep a job after graduation.

The program is currently operative in just two schools in Kent County - in Dover where 90 seniors are being counseled and in Smyrna where the number is 60. The aim is to place these students

in entry level positions in private business or industry after graduation.

J.D.G. is funded only through August of 1980. If it can get the 1/4 million it seeks from the state legislature, it will be able to expand into other school districts. About half of that money is being sought for J.D.G. The remaining \$250,000 would be for school guidance counselors for whom Huffman said the level if federal support is dropping.

-accepted the proposed promotion policy for grades 1 to 8 as the second and final reading. Retroactive to September 1979, the policy is in effect for this

school year.

-hired Keith Love as music teacher at North and East and granted maternity leave to June Ward.

-granted Class II status to the Frederica Volunteer Fire Company as a non-profit community organization. If the company is given permission to use school facilities, it will have to pay only for custodial service at times when custodians would not normally be on duty.

-set May 13 as the school board election date.

## Meetings Set On Murderkill Watershed

Two meetings, one set for tomorrow night, and the other scheduled in early April will be of prime interest to Harringtonians concerned over poor drainage that leaves city residents in the vicinity of West Street in high water after any heavy rain.

The first is a meeting called by the Kent Conservation District for tomorrow evening, Thursday, February 21 at 7:30 p.m. at the Capitol Grange Hall in Milford. This particular meeting is a part of efforts by the U.S. Department of Agriculture to get public input on long term soil conservation projects. One project under discussion will be the proposed Murderkill Watershed which has recently been expanded to include the Harrington area. It has been said that only a large drainage project of this type and the tax ditches it would provide could really solve the drainage problems experienced on the west side of Harrington.

A second meeting under the aegis of the Soil Conservation Service of the U.S. Department of Agriculture will deal specifically with the environmental impact of the Murderkill River Watershed Project. Otis P. Fincher, State Conservationist, has determined that the project will have significant local impact and that it will be necessary to prepare an environmental impact statement. To this end a meeting has been set for 7 p.m. on April 2, at Lake Forest North Elementary School in Felton, Delaware.

Persons who have special interests or knowledge in the matter are urged to attend both meetings.

Local residents actively concerned about the drainage problems include Grace Welch and Rose Cain. Their efforts in getting together a petition and

working with Kent County Soil and Water Conservationist Fred Mott resulted in the area's being included in the 70,000 acre project. The Murderkill River Watershed project originally en-

compassed an area north and west of Felton, east to Bowers, and south to Brown's Branch. It would now extend to southwest Harrington at Welch's Seed Service.

## Seed Certification in Delaware

Providing enough certified soybean seed for Delaware farmers has been a goal of the Delaware Department of Agriculture since it took over the certification program in 1978. It seems that for years there has been a shortage of certified seed produced locally. It is generally believed that growers benefit from planting seed adapted to and produced in our area.

Prior to 1978, the University of Delaware administered the seed certification program. While they did an excellent job, I believe the state has the resources to expand the program. I feel that we can now begin to produce enough seed for our needs.

Since the state has taken over

the certification program, the basic program has not changed much. We've changed standards slightly because they needed some updating. One of the new standards is a tolerance for purple stain. Seed standards allow no more than 3% purple stain in certified soybeans. This is a standard which many of our neighboring states require.

In addition to seed certification, our laboratory is heavily involved in germination of soybean seed for farmers. We highly recommend that all farmers who save seed for their own use have a germination test done by the Department. This will help to determine the value of this seed to the farmer.

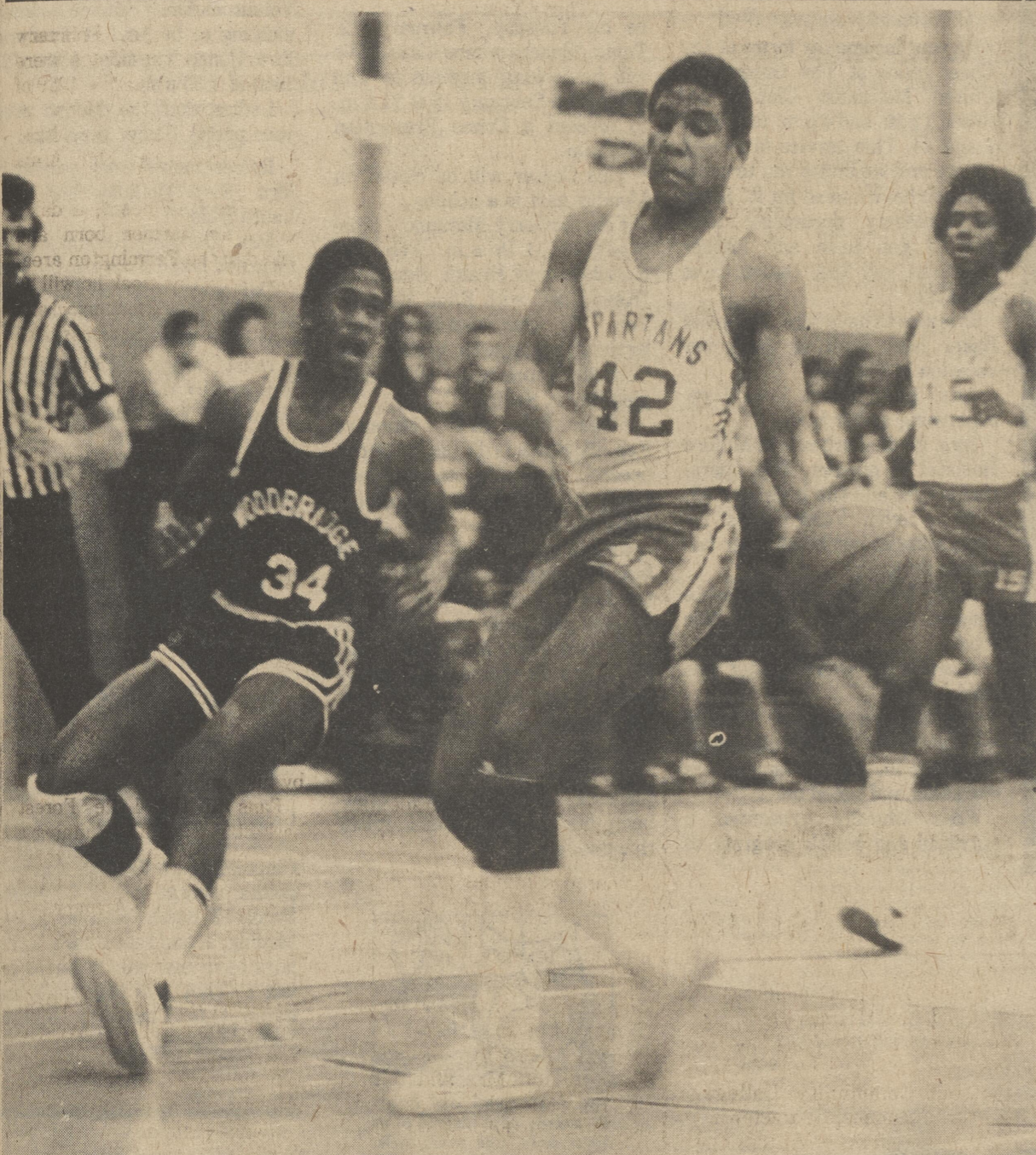

Support the Spartans as they ready themselves for the upcoming state tournament.

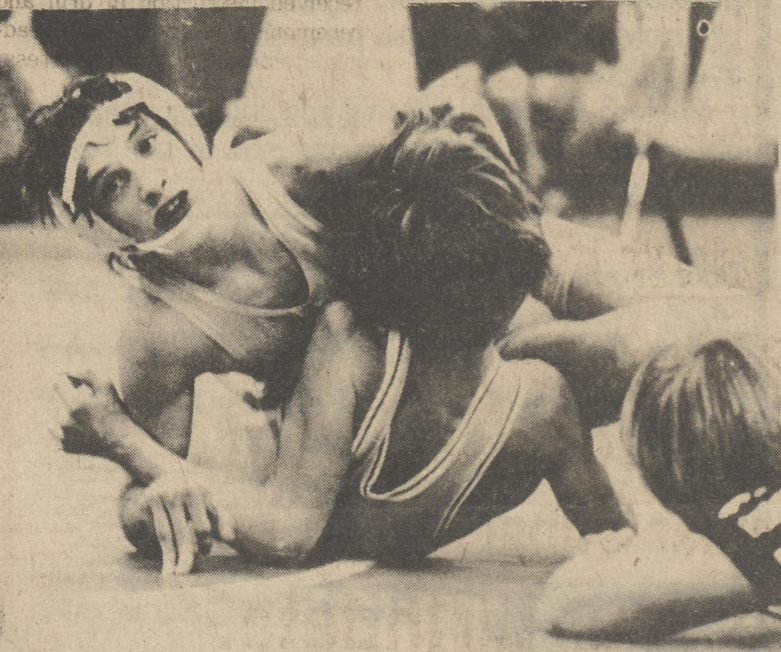
