## Local postal worker saves burning house

"I stopped the car in front of the house...and ran toward the people who were fleeing the house. When I saw they were at a safe distance from the house, I went inside to put out the fire", said Short.

## Lewes teen victim of kidnap

A seventeen year old Lewes, Delaware girl was the victim of a kidnapping and rape Sunday night. The teen was hitchhiking along route 1 from Lewes to Rehoboth. Around 8:30 p.m. near route 24, a motorist stopped to give the girl a ride. She was driven to a beach access road south of Dewey Beach. The victim was forced into the rear seat at knifepoint and raped. She was then released and walked to her home. The teen was taken to Beebe Hospital. The victim described the rapist as a black male with short afro-styled hair, a beard and moustache, an earring in his left ear, wearing jeans and a black jacket. He operated a small, dark colored vehicle. Delaware State Police from Troop 4, Georgetown, are investigating this crime and seeks further helpful information on the rapist.

## Child abuse legislation proposed

State Representative Jerry Buckworth (R-Camden), is sponsoring legislation pertaining to child abuse and the testimony of children in criminal cases. Rep. Buckworth, his intentions are two-fold. He said he wants to weaken the leverage that child abusers exert over their victims. And, he hopes his bills would work to strip away the veil of anonymity behind which many child

abusers act. The first of the three bills charges anyone interfering with the testimony of a child with a 'Class-D' or 'Class-E' Felony. The second piece of legislation permits the videotaping of a child's testimony (age twelve or younger) in a place outside of the courtroom. The third bill in the package removes the exclusion in the existing code whereby a child may be excluded from testifying

in a criminal matter on the basis that he/she does not understand the

# businessman dies

Luigi Antonio Perrone, better known to us as Tony Perrone, Sr. died on Monday, April 9th.

Tony suffered a stroke on Saturday, December 29th which paralized his right side and rendered him speechless. He was a patient at MMH for one month followed by two weeks at Courtland Manor Nursing Home where he remained til March 30th when he went to private care in Milford.

Prior to his illness Tony was a very active member of the Harrington Senior Center, Jolly Timers Band, and Saint Bernadette's Catholic Church. He will be sadly missed by the many friends he had in the community. He is survived by his son, Luigi Antonio Perrone, Jr., known to all as Tony, Jr. of Harrington.

Following is a profile of Tony Sr. as it appeared in this newspaper on May 16, 1974, written by Margo R. Farrow. Since 1933 Harrington has been the adopted home for one of the most well-known businessmen, and above all. craftsman left in the area. Known to most as Tony, Mr. Perrone is truly a member of an age-old craft doomed by the wheels of industry.

To classify him as a repairer of shoes is a travesty for one who has been developing his craft since age nine, spanning over a half century. Life began for Tony in Saint Agata

d'Esaro, a town then the approximate size of Harrington. It lies in the province of Cosenza, Italy.

Vocation and avocation came almost simultaneously into his life when at age nine or ten, he says, he began working on shoes after school, as well as playing the violin. By age 13 he was in business for himself making his own shoes. Somehow he found time to take up the trumpet.

When Tony was 16 his parents and sister, Mary, came to America while he went to Naples to live with an uncle. It was here that his two interests were refined. He not only studied music at the conservatory there, but learned shoe design and the physical aspects of the foot. He remembers having had an original shoe creation every month as part of his assignments, as well as learning to create shoes from the designs on paper to the finished products. He also found time to visit those romantic sounding places...Sorento, Capri, Pompeii...Sunday excursion points for Neopolitans.

In 1932 he came to America, arriving first in New York. From there he joined his family in Ludlow, Pa. Through urging of relatives the Perrones settled in Harrington in 1933, where Tony opened his business.

He has occupied three locations since then. At first he was located where the post office now stands. Across to Fleming Street was the first move, to a building once standing between Raughley Insurance and the Harrington Dry Cleaners. His last move was to the present location on Clark Street.

Tony's father first came to America as a bachelor. He found work in a tannery, although in Italy he had been a farmer and barber. On a return trip to Italy he married Tony's mother. She worked in a silk factory, one of two in the town. As a child Tony took her lunch to the factory. The machinery and materials he saw are still vivid memories. When Mrs. Perrone settled in Harrington, she continued to work with fabrics, finding employment in the Ace Dress Company.

It seems only natural that in 1938 Tony was to return to the home town

to marry. A somewhat remote musing women will, changed her mind. The steals over him when he recalls those days of courtly remancing. One can only call it that because the young men took turns serenading their girlfriends. In groups of three or four with guitar, mandolin and moonlight, how could Francesca resist? She didn't, and their marriage in 1938 continued until her death in 1960.

One surviving child, Tony, Jr. has continued the love of music fostered by his father. It carried him as far as the Peabody Conservatory of Music in Baltimore, Md. He is now employed by Gerardi Brothers in Denton, Md. The Gerardis were the relatives who encouraged the Perrones to originally settle in Harrington.

Several other shoe businesses have competed with Mr. Perrone through the years. At present his is the only one left. It's a casual atmospheric place now, but he recalls working to the point of physical illness during World War II. During those days he stayed open until midnight on Saturday repairing work for people who had come into town for shopping and the movies. Throughout he has generally worked alone, traditionally taking Wednesday for himself. Now, he says he comes and goes as he wishes. Working is something to occupy his time.

The hardest job he has handled over the years was repairing canvasses used to cover truck loads. For those he had to move his stitching machine into the street because of the bulky covers. He still has the orthopedic shoe that

he started to make for a lady who, as and BONA FORTUNA!

shoe still rests on its wooden form, the leather in perfect condition. It's a conversation piece now, a silent testimony to the craftsman. Cost and mass production have made the craft almost extinct now, with a handmade pair ranging somewhere around \$135.

The shoe styles currently popular bring grimaces to our craftsman. "Young girls will cripple themselves in...boxes...junk", advice he freely gives to those who come in his shop. This opinion is also shared by many doctors, so Tony isn't prejudiced against factory-made products.

Of the "old school", Mr. Perrone doesn't mince words with the customer, and he believes in the satisfied customer. During our interview a young woman came in with her husband's work shoes. He looked them over, advised her that they weren't worth the labor and materials involved in the repairing, and offered a substitute pair (same size) for the expense he had in them. It looked like more the third generation of customers.

As of May 1 he has been given notice to move, since projected plans for the construction of a new building are underway for the space his building now occupies. He gives a classic shrug in response to questions about the future. If he can find a new place, well..., if not...we weren't told anything definitely. ## Gab Fest by Pat Hatfield

April 9, 1985, is a date we may wish to put in our diary. We thought we were well into spring with the flowers blooming, the little leaves and buds coming out all over, but last night the Master Painter made us a beautiful picture that looked like Christmas Eve. The red Japonica, the baby purple lilacs in my yard and the golden Forsythia in my neighbors' yard were all decorated with soft, whipped cream snow. And under the evergreen on the ground a wee dove was walking around looking for food where she had found it before.

Dad and I discussed the state of the vegetable garden at breakfast. We decided all was well. The peas are up but they like cold and wet weather. The cabbage plants do not mind and neither do the onions. The potatoes are not up yet.

During the 80 odd years of our life, we have seen these late April snows. In the year 1915 Dad recalled that it snowed all day on Saturday and on that Easter Sunday morning, he went for a sleigh ride.

I remember another April when I was working in Dover for the Conference Board of Religious Education, and when my boss came in that morning he yelled April Fool, since it was the first day of April. I replied that it seemed more like Merry Christmas!. Many of our Delaware snows seem to come in the spring. Even the famous blizzard of '88 was in March.



## Olin offers do's and don'ts on disposing of marine flares to meet federal law

Boaters who must replace their classes expired marine visual distress signals this season are being advised of several "Dos" and "Don'ts" concerning safe and proper disposal of flares and other signal devices.

Federal law requires that all pleasure boats 16 ft. and over using coastal waters or the Great Lakes to carry Coast Guard-approved pyrotechnic signals, which must be replaced 42 months from the date of manufacture. As a result, Olin Signal Products, the leader in recreational marine distress signals, has made several recommendations to the National Boating Safety Advisory Council on Visual Distress Signals (VDS).

Acceptable methods for disposing of flares, including those manufactured in 1981 or earlier include:

• Retaining these flares for back-up use

to expand signalling time in the event of an emergency.

• Donating expired flares to local Coast Guard Auxiliary or Power Squadron for use in their training

### • Ignite handheld flares on land in a safe area, much the same as highway flares would be ignited. · Contact a local law enforcement or

fire protection agency for their advice on proper VDS disposal.

Olin has also recommended these "Don'ts" to boaters who are disposing of expired flares this season:

• Don't jettison VDSs overboard.

• Don't activate marine flares in a non-emergency situation over regulated waters.

• Don't dispose of "live" flares in household trash.

• Don't launch meteor signals on land. especially over or near buildings or trees.






